### 4.1 NWCAC 2016 Meeting Schedule

#### 5.2 NWMO Presentation; The Planning of Field Studies

Ben Belfadhel will present the NWMO's Plan for Field Studies.

Staff Comments: None at this time.

Action: Ben explained that the community will determine where the boreholes will be drilled on municipal owned land. The NWMO will plan to have an open house the first quarter of 2016 highlighting the initial borehole drilling and testing that is being planned. The drilling and testing will take a few months including lab time to study the results. NWMO will take the plan to test borehole drill in Huron-Kinloss back to Council for approval. Huron-Kinloss is in the same phase as a few other communities including that of Ignace. Ignace is in Northern Ontario and along the Canadian Shield which hosts very different geology than Huron-Kinloss.
