## Township of Huron-Kinloss Notice of Passing of a Development Charges By-law

Pursuant to the Development Charges Act 1997, the Council of the Township of Huron-Kinloss has passed a Development Charges By-law. By-law No. 2024-103 passed on November 18, 2024, sets out a range of charges to be collected from new residential development. The development charge by-law applies to all new residential and non-residential development within the boundaries of the Township of Huron-Kinloss. The development charges are calculated on a "per unit" basis for residential development. A key map has not been provided as the service areas are described in the bylaw, available on the Township's website: www.huronkinloss.com

The following tables summarizes the development charges for the service areas. The services being collected for through development charges include Parks and Recreation, Administration, Sanitary Sewage, Water, Stormwater, Roads, Fire and Septage.

Any person or organization may appeal to the Ontario Land Tribunal under Section 14 of the Act, in respect of the development charge by-law, by filing with the Clerk of the Township of Huron-Kinloss on or before the 28<sup>th</sup> day of December, 2024 a notice of appeal setting out the objection to the by-law and the reasons supporting the objection.

Appeals may be submitted in person at the Township Office during regular office hours, using the drop-box at the Township Office outside of regular office hours, via mail to 21 Queen Street, Ripley ON attn: Clerk, or via email to <u>clerk@huronkinloss.com</u>. The appellant is advised to contact the Ontario Land Tribunal to access the required forms and applicable Provincial fees.
